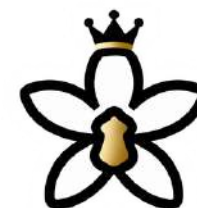

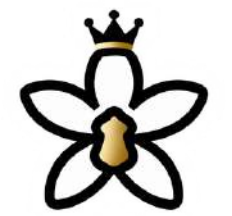
OVERVIEW

Indonesia has solidified its position as a leading global supplier of premium vanilla, renowned for its rich aroma, high vanillin content, and sustainable cultivation practices. According to the Food and Agriculture Organization (FAO), Indonesia accounted for approximately 30.3% of global vanilla production in 2020, yielding around 2,306 tons, thereby securing its rank as the second-largest producer worldwide.

The country's tropical climate and fertile soil provide ideal conditions for the cultivation of *Vanilla planifolia*, the same species produced in Madagascar, which is highly sought after in the global market. This favorable environment enables continuous production cycles, ensuring a steady supply to meet international demand.

In terms of exports, Indonesia has demonstrated significant growth. In 2019, the country exported vanilla worth approximately \$69.6 million, with the United States being the largest importer, accounting for \$43.3 million of this total. By 2023, Indonesia's vanilla exports were

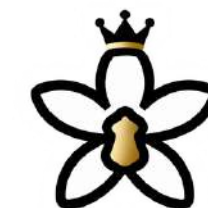

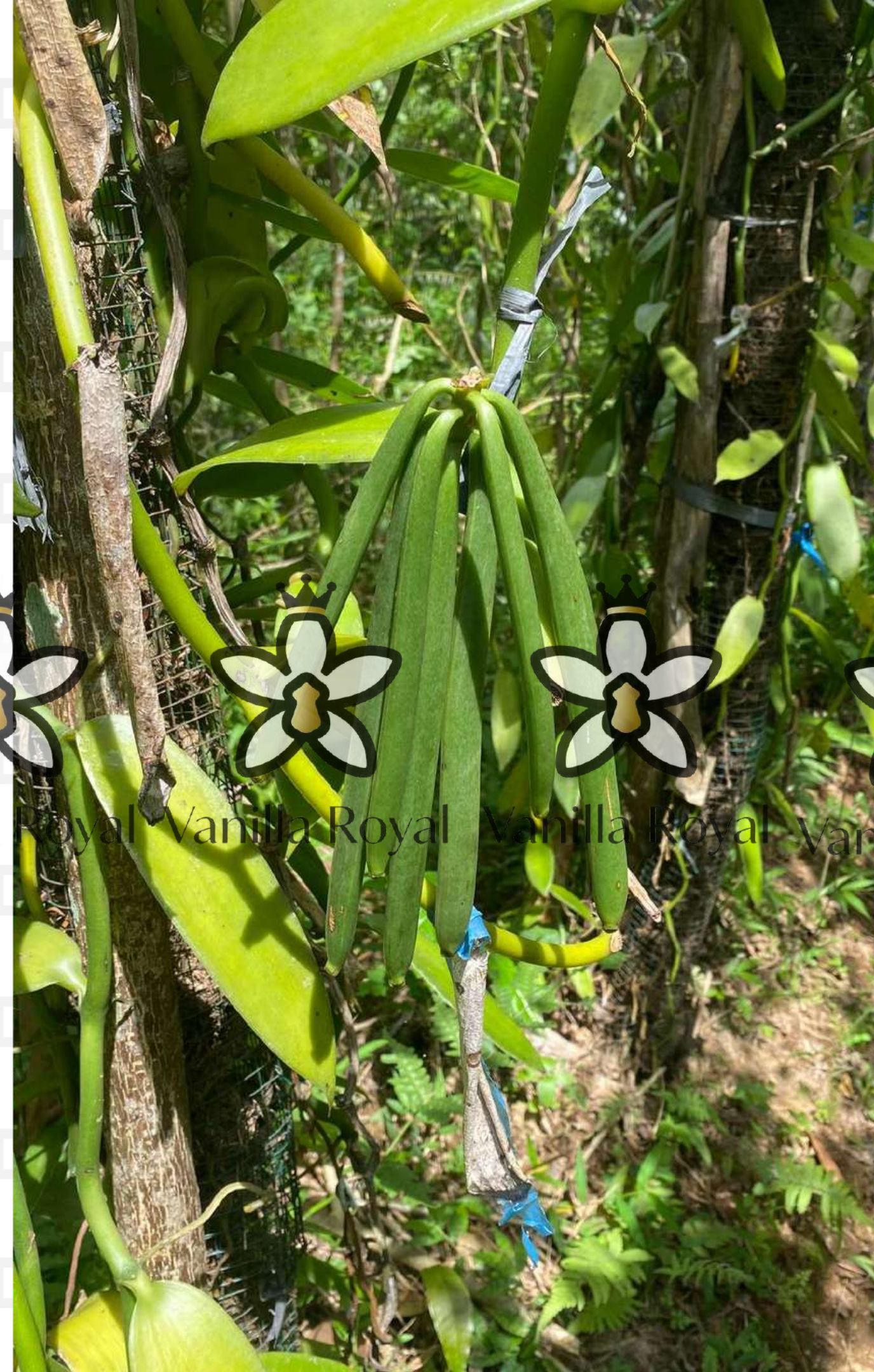

 - CIF: PT Worldnesian arranges shipping & insurance to the buyer's destination.A final quality inspection is conducted before dispatch.



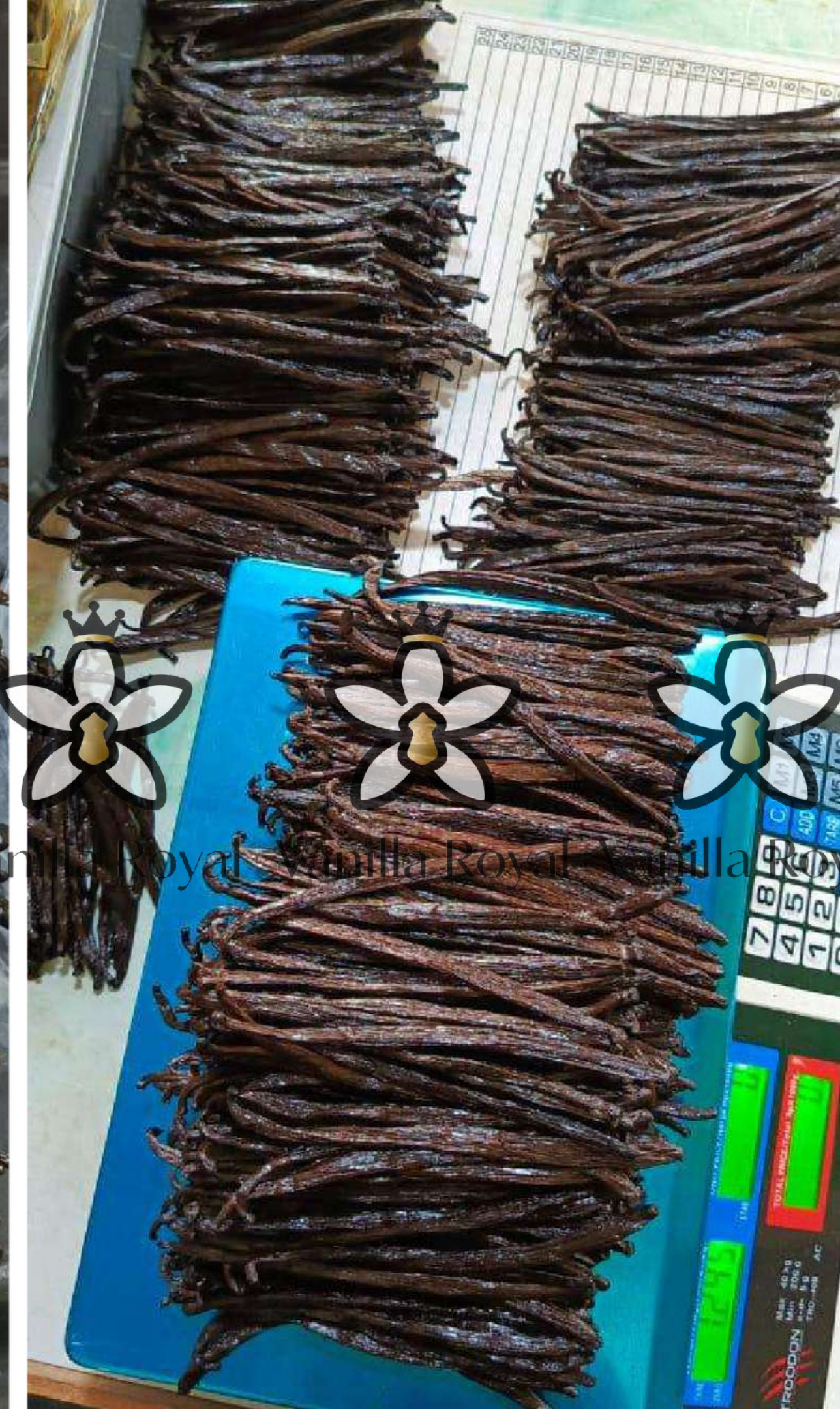

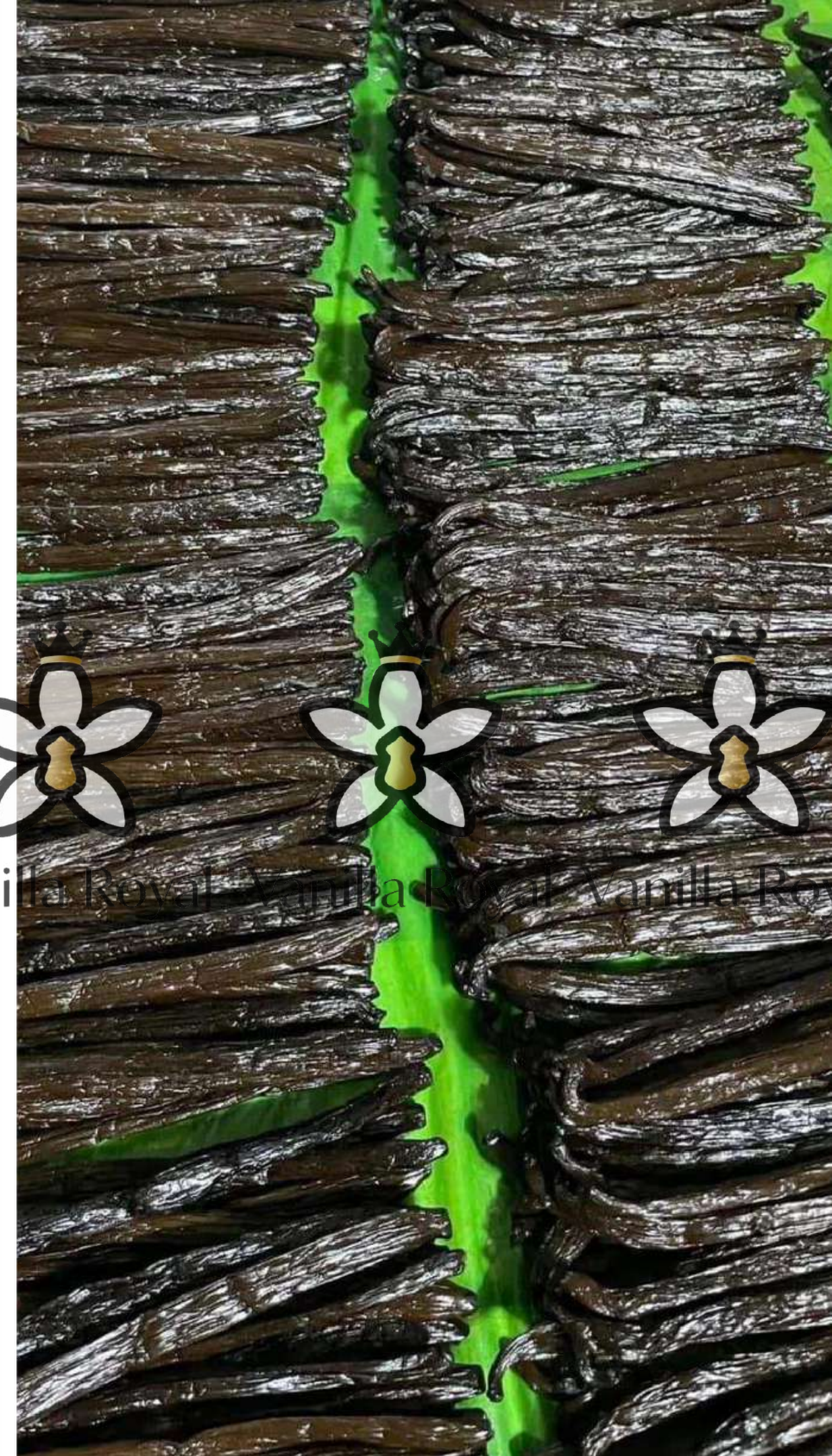

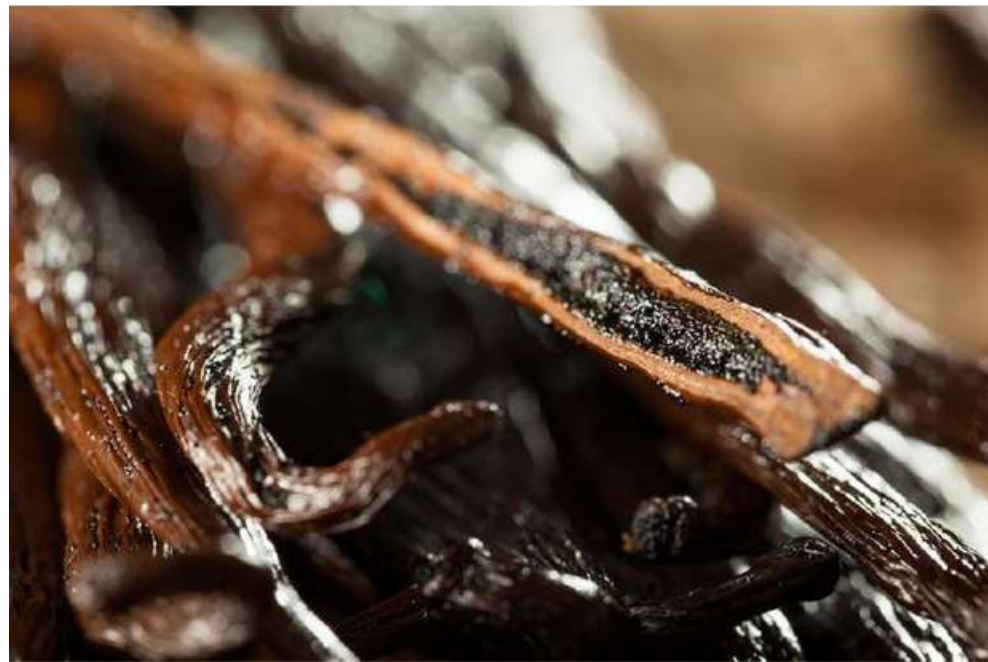
